A. Forecast for Anticipated Financial Resources – 55 min (Lincoln, Aaron and Marilyn)

A review of the current and future financial resources available to the Land Bank, including existing commitments for those resources. What should expectations be for matching funds from federal, state and other sources?

Discussion Questions

➤ Though there is a 2025 budget it does not currently include any conservation projects. What are people seeing as clear priorities for the coming year?

B. Acquisitions – 35 min (Lincoln, Doug, Amanda, and Peter)

With limited financial resources it is helpful to have a sense from the Commission about how/where the Land Bank should focus its acquisition activities in the coming year. The focus could be on types of land or targeting specific islands. Does what you heard during the renewal initiative influence your thinking?

Discussion Questions

In general terms, what should the Land Bank priorities be for acquiring lands/easements during the coming year? (This is not meant to be a parcel-specific conversation.) Where and what types of lands? Where are gaps that should be addressed, or needs that should be met?

C. Stewardship – 40 min (Lincoln)

In the recent past there has been an emphasis on creating and improving public access to Land Bank properties. At the same time, ecological stewardship activities have taken on added importance. What are examples of important additional public access projects? What are examples of important ecological stewardship activities?

- The land Bank will undoubtedly continue to provide stewardship activities that support public access <u>and</u> provide ecological stewardship, but in a time of more limited resources where should the organization prioritize its resources?
- What would it take to accomplish stewardship priorities, in terms of staff and financial capacity? Can use of volunteers add to our staff capacity in meaningful ways?

During the renewal initiative there was a high level of activity regarding communication and community engagement. Is that level of activity sustainable going forward? If not, where should work be focused?
